



**TEMPORARY CLOSURE VARIOUS
(HARDWICKE PARISH) STROUD DISTRICT**

Gloucestershire County Council intend to make an order under the relevant provisions of the Road Traffic Regulation Act 1984 (as amended) to temporarily close and restrict part of the roads as described in the schedules below.

The reason for the closures and restrictions is for the construction of the Junction on the A38 North and Southbound at B4008 Bristol Road.

The roads are expected to be closed and restricted on a rolling programme commencing 15th August 2021, where the presence of approved signage will indicate whether the closure and restriction is in force. Further advance warnings of dates/times will be displayed on site prior to the closure and restrictions taking effect. This order can permit the closure and restriction of the roads in any order, or simultaneously as required and it is anticipated all works will be completed by 30th September 2022.
