Levels of Service for issuing consents

Please be advised that the consent (compliance and share/ members certificate) must be signed by directors of the residents company who in many cases are living on the residents company estate. We therefore require up to 10 working days following receipt of all the above requirements to send and receive signed documentation from them and pass onto you.

Service Charges

Any sums outstanding to the residents company must be paid before completion of the property transfer / issue of a compliance certificate. Please contact Preim on the day of completion for an up to date balance. Alternatively, the shareholder or member may access this anytime using their shareholder or member login.

Once completion has occurred, it is the owners' responsibility to cancel any direct debits associated with the property.

The sellers' and buyers' solicitors are solely responsible for any apportionment calculation required at completion.

Please be aware that should a customer claim back any direct debit payments through an indemnity claim, the service charge amount outstanding will increase, this must be paid in full before Preim will issue consent.

If the share or member certificate has been lost and you no longer hold it, then Preim will accept a written statement from the sellers confirming the same and Preim will issue a new certificate in the purchasers name upon completion.
